* The Three Months Free Payroll and SUI Service and Two Months Free Human Resource Essential (HRE) services Promotion (the "Promotion") will run from 3/27/20 – 5/28/20 ("Promotion Period") unless ended earlier by Paychex and is subject to the following terms and conditions. The Promotion shall consist of (i) Three (3) months of free payroll and SUI services; and (ii) Two (2) months free HRE Services; and (iii) No set up fee. The Promotion shall be available to eligible clients during the Promotion Period. An eligible client shall be a client who (1) is not currently receiving payroll services from Paychex; (2) elects the Paychex Flex® Enterprise, Paychex Flex® Pro or Paychex Flex® Select, or Paychex Express payroll service agreement and the Paychex HRE service agreement; and (3) commences payroll services on or before the end of the Promotion Period. Paychex will credit Client's free payroll in months one, two and nine following commencement of payroll services. If Paychex invoices SUI services separately Paychex will credit Client's three months of free SUI in months one through three following commencement of SUI services. Paychex will credit Client's two months of free HRE in months one and two following Client's execution of the HRE service agreement. Client must elect all three services (payroll, SUI and HRE services) to be eligible for the Promotion. Client shall be responsible for fees for each of the services following the completion of the free credits. Any unused month is not redeemable in U. S. currency or for any other entity. Client shall be solely responsible for all fees due for services other than payroll, SUI or HRE Services. The Promotion cannot be combined with any other offer and is only available during the Promotion Period.
